INVITATION TO BID

The City of Ennis is inviting vendors to bid on patrol rifles for the Ennis Police Department. The specifications are as follows:

Sealed bids, addressed to Finance Director, City of Ennis, Texas, will be received at City Hall, 107 North Sherman Street, or mailed to P.O. Box 220, Ennis, Texas 75120 until 10:00 A.M. on Tuesday March 7th 2023.

TERMS AND CONDITIONS

Submission of Bid

Bids shall be submitted in a sealed envelope with a copy of the vendor's official bid and a completed copy of the Form CIQ found on the Texas Ethics Commission website <https://www.ethics.state.tx.us/data/forms/conflict/CIQ.pdf>. The envelope shall be clearly marked in the top left-hand corner with the vendor's name and return address.

Deadline

All bids must be submitted prior to 10:00 A.M. on Tuesday, March 7, 2023. Any bids received after this time will be returned unopened. Bids must be mailed, or delivered to, 107 North Sherman Street, Ennis, Texas 75120.

Contract

This bid, when properly accepted by the City of Ennis, shall constitute a contract equally binding between the successful bidder and the City of Ennis, Texas. City may delay acceptance of bids for 30 days from date of opening.

Prices

Bid prices must be firm for one (1) year after bid opening date. The city is exempt from sales tax; do not include tax on bid. Unit price should reflect all charges, including any and all shipping costs. Once the bid is awarded, a copy of the City of Ennis Sales Tax and Use Exemption Certification will be provided to the vendor that is awarded the contract.

Delivery

Bid price shall include all shipping and delivery charges to the City of Ennis Police Department, 1700 West Lake Bardwell Drive, Ennis, Texas 75119. Successful bidders must deliver within 120 days after the date in which the order is made. The date of purchase will be considered the date that a purchase order is delivered to the vendor.

Payment

Payment will be made within 30 days after receipt and acceptance by the city of item(s) ordered and the receipt of a valid invoice.

Alterations by Bidder

Bids cannot be altered or amended after opening time. Any alterations made before opening time must be initialed by bidder or his authorized agent. No bid may be withdrawn after opening without approval, and based on written, acceptable reason. Bids received after closing time will be returned unopened.

Addenda

The City reserves the right to revise or amend the specifications prior to the date set for opening bids. Such revisions or amendments, if any, will be announced by addenda or addendum to these specifications, copies of such addenda so issued will be furnished to all prospective bidding parties.

Assignment

The successful bidder shall not sell, assign, transfer or convey this contract in whole or in part, without prior written consent of the City of Ennis, Texas.

Venue

This agreement will be governed and construed according to the laws of the State of Texas. This agreement is performable in Ellis County, Texas.

Documentation

Bidder shall provide all documentation required by this invitation to bid. Failure to provide this information may result in rejection of bid.

Minimum Standards for Responsible Prospective Bidders

A prospective bidder must affirmatively demonstrate bidder's responsibility. A prospective bidder must meet the following requirements:

1. Have adequate financial resources, or the ability to obtain such resources as required.
2. Be able to comply with the required or proposed delivery schedule.
3. Have a satisfactory record of performance.
4. Have a satisfactory record of integrity and ethics.
5. Be otherwise qualified and eligible to receive an award.

The City of Ennis, Texas may request information sufficient to determine bidder's ability to meet the minimum standards listed above.

Termination for Default

The City of Ennis, Texas reserves the right to enforce the performance of this contract in any manner prescribed by law or deemed to be in the best interest of the City in the event of a breach or default of this contract. The City of Ennis, Texas reserves the right to terminate the contract immediately in the event the successful bidder fails to:

1. Meet schedules;
2. Pay any required fees; or,
3. Otherwise perform in accordance with the bid specifications.

In the event the successful bidder shall fail to perform, keep or observe terms and conditions of this bid, the City of Ennis, Texas shall provide written notice of such default; and in the event said default is not remedied to the satisfaction and approval of the City of Ennis, Texas within two (2) working days of receipt of such notice by the successful bidder, default may be declared and all the successful bidder's rights shall terminate.

Remedies

The successful bidder and the City of Ennis, Texas agree that both parties have all rights, duties, and remedies available as stated in the Uniform Commercial Code.

Silence of Specifications

The apparent silence of these specifications, terms, and conditions to any detail, or to the apparent omission of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practices are to prevail. All interpretations of these specifications shall be made on the basis of this statement. The City reserves the right to revise or amend the specifications prior to the date set for opening bids. Such revisions or amendments, if any, will be announced by addenda or addendum to these specifications, copies of such addenda so issued will be furnished to all prospective bidding parties.

Award

The City of Ennis will award the bid to either the lowest responsible bidder or the bidder who provides the goods or services at the best value for the City of Ennis. In awarding the bid, the following criteria will be used:

1. The purchase price; and
2. The reputation of the bidder and of the bidder's goods or services; and
3. The quality of the bidder's goods or services; and
4. The extent to which the goods or services meet the City of Ennis' needs; and
5. The bidder's past relationship with the City of Ennis; and
6. The impact on the ability of the City of Ennis to comply with laws and rules relating to contracting with historically underutilized businesses and non-profit organizations employing persons with disabilities; and
7. The total long-term cost to the City of Ennis to acquire the bidder's goods or services; and
8. The criteria listed under the other sections of the Terms and Conditions of this bid packet as well as the Specifications.
