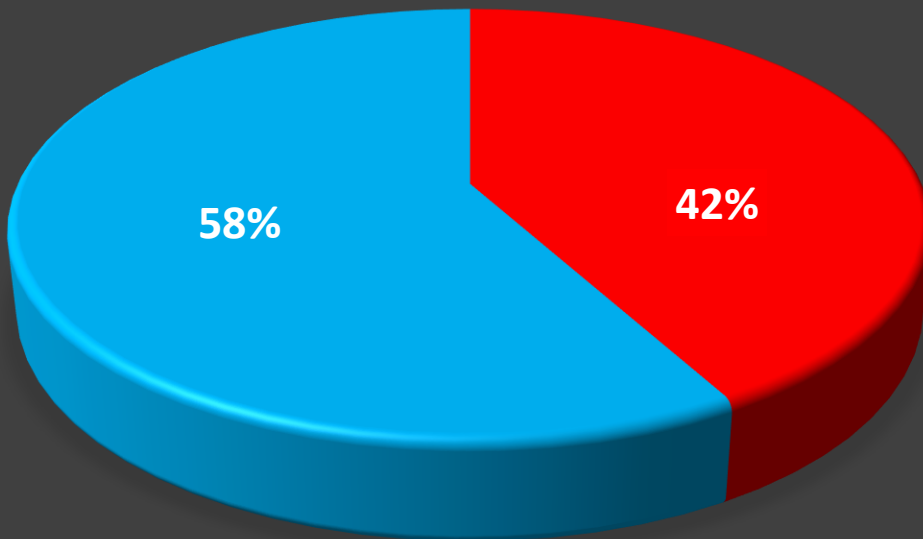
# OPERATIONAL STATISTICS

The average total response time for fire apparatus in the month of October was 5:01. The total call volume for the month of October was 317 responses. The ratio of fire to EMS incidents is 42% to 58% respectively.

We averaged 10.2 calls per day for the month.

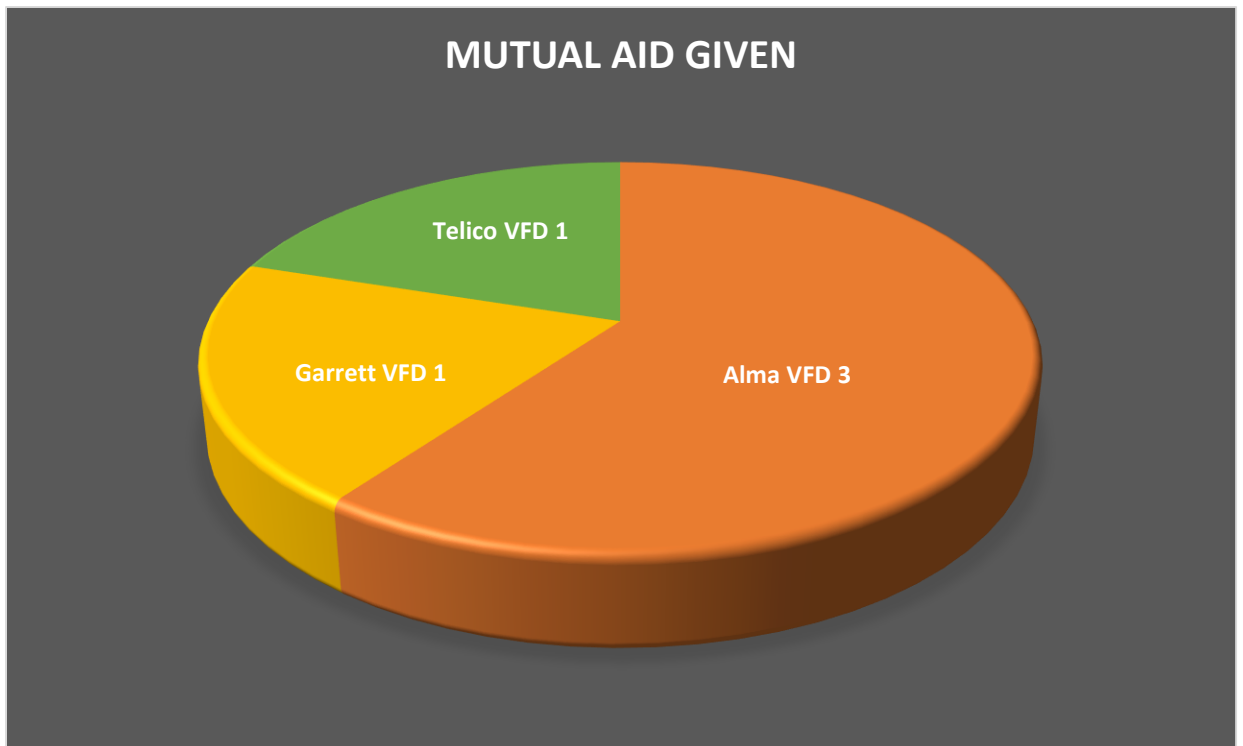

We had 5 mutual aid responses for the month.



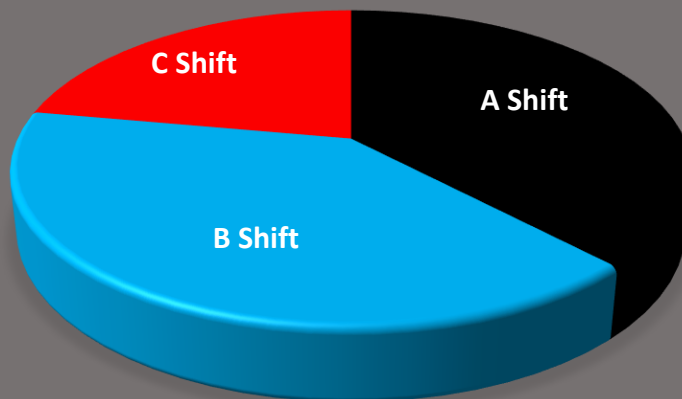
